HB/CTB cases awaiting decision by the Upper Tribunal

- 1 Decision Making and Appeals (DMA) Leeds is aware of the following Housing Benefit/Council Tax Benefit (HB/CTB) cases that are awaiting decision by the Upper Tribunal (UT)
 - CH/15/09: Whether comprehensive sickness insurance is waived in the circumstance that a Swedish national has a sickness benefit exported under 1408/71
 - CH/2733/2009: HB disallowed on the grounds of capital before a decision was made on Pension Credit (PC). UT have asked if the tribunal erred in law by making a decision before the decision was made on the PC claim
 - CH/2823/2009: Local Housing Allowance (LHA). Disabled student – carer's room
 - CH/3000/09: Whether foster children are occupiers of the dwelling
 - CH/208/2010: Date of permanent residence in nursing home – HB overpayment – Tribunal's consideration of evidence
 - CH/247/10: Separated couple. Whether child is an occupier of claimant's dwelling
 - CH/322/10: Meaning of sheltered accommodation
 - CH/801/2010: Whether size criteria discriminate against disabled people
